ANNUAL TRAINING 71 COMES TO A CLOSE

All units of the Kentucky Army National Guard have completed Annual Training 1971, and are now preparing for their next round of activities which are the Annual General Inspections starting next month.

New Cumberland, Pennsylvania

The 2113th Transportation Company (Aircraft) pulled their two week stint of AT from 26 June-10 July 71 at New Cumberland Army Depot. Their training consisted of actual on-the-job training on aircraft of the regular forces which are processed through the depot for repairs and modifications.

Camp Pickett, Virginia

During the period of 23 July-8 August 71, a total of 3,248 members of the Kentucky Army National Guard performed their training in the white sand areas of Camp Pickett, Virginia.

The Kentucky Army National Guard under the leadership of MG Larry C. Dawson, The Adjutant General, supervised the training conducted in the areas of artillery firing, signal communications, medical evacuation, military police duties and logistical support activities.

The XXIII Corps Artillery, commanded by BG Robert R. Goetzman, spent their time conducting artillery exercises which culminated with Army Training Tests of units of the 1-623d Artillery, 5-138th Artillery and Battery A (Searchlight) 138th Artillery.

The 138th Artillery Group, commanded by COL Wilbur R. Buntin, Jr. in addition to their normal duties of supervising training of the 23d and 38th Signal Platoons, the 441st Medical Detachment (Helicopter Ambulance), and the 149th Military Police Battalion, also participated in some Artillery activities by conducting an evaluation of the training of the 2-138th Artillery, a unit of the XXIII Corps Artillery.

BROADER-GREATER INSURANCE COVERAGE AVAILABLE TO GUARDSMEN

Due to recent changes authorized by the Executive Council of NGAKY, the Association's Insurance Committee may now offer to all Kentucky Guardsmen, broader and larger amounts of coverage through the NGAKY Insurance Program.

Effective May 15th, Guardsmen may purchase a \$15,000 Association life insurance policy which is written the same as the previous \$5,000 and \$10,000 policies the Association has offered since 1967—that is a full time coverage with no exclusions in the event of death. Association officers are proud of the fact that their policies provide for payment of a claim in the event of death from any cause—at any time. Claims are normally paid within 24 hours of the receipt of notification of death.

The married Guardsman is now additionally able to insure his wife and all of his children (from 3 to 21 years old) in the amounts of \$1,000 each. Children under 3 are insured for lesser amounts. This feature, called "Dependant Coverage" became available in November 1970 and already 636 guardsmen have signed up. The Dependant Coverage feature may be added to any existing or new policy at a cost of only \$2 per quarter.

The new \$15,000 policy cost is computed at the same low premium rate used for the \$5,000 and \$10,000 policies. The new policy cost is \$16 per quarter. The \$10,000 policy is still \$11 per quarter and the \$5,000 policy remains at only \$6 per quarter.

RECRUITING HELP FOR ARNG

WASHINGTON, D.C.—Regular Army soldiers who join the National Guard before separation are being offered a release 60 days prior to their normal separation, according to a spokesman in the Pentagon.

The early release idea is part of a major new in-service recruiting campaign that is being tried out on a 90-day experimental basis at Ft. Knox, Ky. and Ft. Lewis Wash. The Active Army will attempt to convince a man to re-enlist, before he is referred to the Guard or Reserves.

A Guard and Reserve counselor will be located at both installations during the 90-day experimental program.

Fort Hood, Texas

The 1-123d Armor convoyed a total distance of 1,600 miles round trip to complete their two weeks of training at Fort Hood, Texas.

The battalion is married up with the 3rd Brigade of the Second Armored Division, a regular army unit. The people at Hood are always amazed at how a National Guard battalion can make such a trip but then they do not know how we Kentuckians, and particularly the 1-123d Armor always accomplishes the mission. The tank training received by the members of this battalion was outstanding.

Fort Knox, Kentucky

While the bulk of the Kentucky Army National Guard was going through their paces at Camp Pickett the 223d MP Co (Guard), a unit of the 149th MP Bn, was doing military police duties at Fort Knox, Kentucky to include Stockade guarding activities. The compliments passed on to this unit by the Fort Knox Military Police Commander and Evaluators were of such calibre as to give considerable pride to the unit commander.

THE AG SPEAKS

All units of the Kentucky Air and Army National Guard have returned from Annual Training. I was highly impressed with the professional attitudes and training I observed in performing the objectives each unit had to attain.

The Kentucky National Guard is in the process of receiving its authorized share of unit and individual equipment, but with this gain we must emphasize the maintenance of this equipment. I will be looking to all members of the Kentucky Guard, in positions of leadership, to vigorously pursue the area of preventive maintenance of this new equipment.

Recruiting and Retention is one of our major areas of concern, and towards this end we now have a full time Recruiting and Retention Officer, whose main purpose is to assist the unit recruiters and counselors at each level of command. We must continually strive to retain the fine members of the Kentucky National Guard we have on board. Those that we lose must be replaced immediately with a new recruit.

During September and October the Annual General Inspections for all Kentucky Army National Guard units will be conducted. The emphasis we must continue to pursue is in the area of preparing for these inspections. This is a "team" effort meaning that all unit members must prepare for these inspections. I will be looking at the results of these inspections as indicators of maintenance training and administration.

AG APPOINTMENTS

MG LARRY C. DAWSON, The Adjutant General, announced the appointment of LTC ARMANDO J. ALFARO, as the Kentucky Army National Guard Recruiting and Retention Officer, effective 15 August 1971.

Prior to his appointment LTC Alfaro was assigned the technician position of Staff Administrative Assistant to the old XXIII Corps Artillery and the 138th Artillery Group, located in Lexington, in which he served for a total of 18 years, of his 26 years of military service.

MG Dawson stated that the responsibilities of LTC Alfaro will include the development of a statewide R&R program and SOP; the development, planning procurement and distribution to the units of R&R material for use in the printed and audio/visual news media; unit distribution of materials prepared by NGB; planning and supervising recruiting seminars and briefings for unit recruiters; and the maintenance and consolidation, as necessary, of such R&R reports as required by the Adjutant General of Kentucky and the Chief, National Guard Bureau.

LTC THOMAS J. MURPHY, Frankfort, HHD KyARNG, was promoted from Military Support Plans Assistant to Military Support Plans Officer, by MG Larry C. Dawson The Adjutant General, effective 1 August 1971.

LTC Murphy had served in his former technician capacity for a period of six years.

In his new position, LTC Murphy is responsible to The Adjutant General for assisting in the planning, coordinating and the controlling of all resources made available by all the services for the Military Support of the Civil Authorities responsible in domestic emergencies.

MAJ THOMAS BUYHER, formerly Administrative Assistant to 5-138th Artillery, Lexington, has been re-assigned duties as Military Support Plans Assistant effective 1 August 1971, in the office of The Adjutant General, Frankfort.

His principal duties are to assist in the development and reviewing of the statewide plans for military support of civil authority, including military forces in support of civil authorities in the event of a domestic emergency for specific courses of actions.

Major Buyer's military career spans a period of 26 years of service.

REPORT FROM THE PRESIDENT

The second Executive Council meeting since our State Convention was held on 13 July at Park Mammoth, Ky.

We welcome a new member to the Council, MAJ Edward Ratcliff.

We are proud of the work the committee on Insurance formerly under the direction of LTC James Pickett and now under the direction of LTC Shelby T. Bush, is doing. This committee with foresight and the interest of Guardsmen at heart has undertaken two outstanding improvements in benefits available to us. In the early spring Dependent coverage was added and now the limit on Insurance to Guardsmen is increased from \$10,000 to \$15,000. Of course, after one year in the program the \$15,000 becomes \$17,000 of Life Insurance, all for \$64.00 per year.

The delegates appointed to the 93 NGAUS Conference in HAWAII were announced and the council voted to allot each delegate \$160.00 for expenses. This is the same as we have done the last two years.

The committee on Constitution and By-laws under the direction of MAJ Bird has completed its sample mailing of the questionnaires to Enlisted Men on their interest in becoming members of our state association. They will be meeting again in the next few weeks to compile the data they have collected. We will keep the membership informed of these results.

My latest correspondence with the NGAUS still shows our organization to be more highly involved in Reserve Military Affairs. Most of our key legislation is still in committee and almost every week a NGAUS Executive is invited to the hill to testify on National Guard matters and legislation.

Still very much alive are bills to reduce Military retirement to age 55; Re-enlistment Bonus; Survivors Benefits; Civil Service retirement for technicians, 100% credit; and several other lesser bills.

CHARTER PLANE TO HAWAII NEARLY FULL

AWARD OF NATIONAL DEFENSE SERVICE MEDAL

The Deputy Chief of Staff for Personnel, Department of the Army has advised the Chief, National Guard Bureau, that the National Defense Service Medal may be awarded to members of the Army National Guard who are called or ordered to Federal Active Duty (except for periods of Active Duty for training) regardless of duration.
